





Memorandum of Understanding
 Redwoods Community College District (District)
 College of the Redwoods Faculty Organization (C.R.F.O.)

The RCCD and CRFO agree to temporarily separate the management and counseling responsibilities of the TRiO position at the Del Norte campus for the 2025–2026 academic year.

This agreement is necessary because the faculty member previously serving in the combined TRiO role has been reassigned to a permanent tenure-track counseling position.

The District intends to use available TRiO grant funds to employ an associate faculty counselor to provide TRiO-related counseling services during the 2025–2026 academic year.

This MOU applies only to the 2025–2026 academic year. Future funding and staffing decisions for TRiO services will be reassessed based on the availability of grant support beyond that year.
