## **Introduction**

The North Coast Concurrent Enrollment (NCCE) pathway was designed to offer College of the Redwoods (CR) associate degree, registered nursing students an associate degree/baccalaureate degree Concurrent Enrollment Program (CEP) option in collaboration with California Polytechnic University, Humboldt. The NCCE was created in response to the Institute of Medicine's goal to increase the number of Bachelor of Science in Nursing (BSN) degree graduates to 80% by 2020 and the call by the National Education Progression in Nursing Collaborative for innovative, seamless education progression models in nursing.

The NCCE pathway provides qualified CR Associate Degree Nursing (ADN) students a quality, affordable, and accessible pathway for completing a BSN within one (1) year after graduating with their ADN. Students enrolled in the NCCE program follow the traditional course of study for all CR ADN students while simultaneously enrolling in required CSU BSN courses. The CEP curricular pathway is designed to be complementary to the ADN coursework. CSU courses are offered to students through innovative hybrid formatting, with most of the coursework taught online, asynchronously, plus a one-day intensive twice each semester (once on campus and once via Zoom). CEP applicants accepted into the CR ADN program in the fall semester will be enrolled in the Cal Poly Humboldt pathway (See Table 1 for the course roadmap). Upon completion of the CR ADN program, graduates are eligible and required to take the NCLEX-RN licensure examination to continue in the CSU program.

Potential employers highly value BSN-prepared graduates because advanced education has been shown to improve patient outcomes and reduce hospital costs. The NCCE program graduates will have the knowledge and skills to begin their nursing career with a degree promoting professional knowledge and advancement while improving the health outcomes in the North Coast region and beyond.

### **Accreditation:**

College of the Redwoods (CR) holds accreditation from the Accrediting Commission for Community and Junior Colleges (ACCJC) of the Western Association of Schools and Colleges (WASC). The ACCJC is an institutional accrediting body recognized by the Council for Higher Education Accreditation and the U.S. Department of Education. ### **CR-Cal Poly Humboldt Concurrent Enrollment Program Information**

The CR-Cal Poly Humboldt CEP is a three-year program for qualified participants selected from a pool of CR ADN students who have met all CEP program eligibility requirements and have applied for admission to the CEP.

## Eligibility

To be considered for participation in the CEP, the following is required:

1. Register for and attend a CEP Information Session.
2. Submit official transcripts to the College of the Redwoods from all previous institutions attended.
3. Complete the CR nursing program application. Indicate on the application the Concurrent Enrollment Associate Degree of Nursing(ADN)/BSN option.
4. Complete all CR, CSU prerequisite, and lower division CSU general education requirements (see Table 1: CR-Cal Poly Humboldt CEP Pre-Nursing Pathway).
  - Applicants who have completed a bachelor's degree will complete all CR and CSU prerequisite requirements for admission.
5. Make an appointment with a counselor or advisor at College of the Redwoods to go over your progress toward satisfying CSU general education requirements to go over your progress towards fulfilling lower division CSU GE categories A, B, C, D, and F to make a plan to complete any missing requirements prior to applying to the program.
6. Complete all Humboldt CR CEP nursing pre-admission required courses with a minimum grade of C or higher.
  - Oral Communication (CSU GE A1)
  - Written Communication (CSU GE A2)
    - ENGL 1A Written Communication [CR Nursing pre-admission requirement]
  - Critical Thinking (CSU GE A3)

    - or an accepted substitute such as:

7. Meet a minimum cumulative GPA of 2.75 from all transferable coursework from all prior institutions attended.
  8. Maintain a 2.0 grade point average in all coursework while enrolled in the CEP program.
  9. Maintain Satisfactory Academic Progress for financial aid eligibility.

### Key Information

1. Students must meet all prerequisite requirements for acceptance into the CR ADN program (See Table 1).
2. Additionally, students must complete all indicated CR and CSU lower division GE requirements before applying to the program (See Table 1).
3. Application and acceptance into CSU are determined after eligibility for the NCCEP is approved and finalized by CR.
4. CSU courses are offered to students through innovative online or hybrid formatting. However, students must attend a 1-day face-to-face intensive twice each semester.
5. After completing the ADN degree, all face-to-face meetings scheduled for CSU courses in the 5<sup>th</sup> and 6<sup>th</sup> semesters are held on the CSU campus.
6. CEP students admitted to the fall CR ADN cohort become part of the designated Cal Poly Humboldt ADN-to-BSN cohort,
7. Students assigned to a CSU campus upon admission into the CEP are ineligible to switch CSU campuses.
8. Students placed into the traditional CR ADN cohort are not eligible to transfer into the CEP program at a later time. Upon graduation with their ADN, students can apply to the traditional RN-BSN program.
9. CEP students must maintain a 2.0 GPA in all coursework once admitted.
10. After graduation from CR, students must take NCLEX-RN as soon as possible to be awarded transfer unit credit at the respective Humboldt through successful passage of NCLEX-RN.
11. Students need to "have an active, unrestricted California Registered Nurse (RN) license with no disciplinary action pending or imposed before enrolling in NRS 470/NRS 471". Failure to do so may result in the student not completing their BSN degree in the designated time frame.
12. Students must sign an Acknowledgement of Understanding form that identifies necessary contingencies for continuation in the CEP from enrollment until ADN graduation and subsequent ADN-to-BSN coursework completion at Cal Poly Humboldt campus.

CEP students entering in Fall 2024 are allowed to follow the revised 34-unit Cal-GETC lower division General Education pattern. Although the labels above refer to CSU GE areas, the overall totals refer to the new Cal-GETC pattern (e.g. lower division GE Area C is only 6 units total, rather than 9 units).

### Transfer Credits

CEP students may transfer up to 70 transferable semester units to Cal Poly Humboldt from an institution which does not offer bachelor's degrees or their equivalents, for example, community colleges such as College of the Redwoods. Transfer credits may include major, general education units, and elective credits. Students may be awarded up to 10 lower division units and 7 upper division units using the standardized external National Council Licensure Examination NCLEX-RN

to demonstrate prior learning of the pre-licensure art and science of nursing required by the Board of Registered Nursing.

NCLEX-RN units can only be awarded after transcript evaluation through the CSU policy governing the process of credit by external exam. In addition, CEP students with additional credits or a degree from a four-year regionally accredited college or university will be awarded transfer unit credit based on an individual review of their record. Awarding of unit credit for NCLEX-RN and baccalaureate coursework or degree is based on CSU Executive Order 1084, which outlines the CSU Systemwide Nursing Policy governing baccalaureate nursing degrees pursued in post-baccalaureate standing (<https://www.calstate.edu/eo/EO-1084.html>).

CEP students with a prior baccalaureate degree must pay post-graduate CSU tuition fees per CSU Board of Trustees policy.

## Financial Aid

Because federal regulations require that financial aid can only be disbursed through one college or university, CR-Cal Poly Humboldt CEP students must apply for financial aid and complete necessary documents through their Cal Poly Humboldt campus. The CR Promise financial aid program, formerly called the Board of Governors tuition waiver, remains in place and is not affected by the Cal Poly Humboldt and CR agreements.

You will likely be asked to pay your CR nursing program tuition before you receive your Cal Poly Humboldt financial aid disbursement (term start dates may vary between campuses). Be prepared to pay your CR nursing program or your Cal Poly Humboldt tuition out-of-pocket or by installment plan until the balance of your financial aid is disbursed by Humboldt. **Please note that your financial aid is based on individual eligibility and may not be enough to cover your tuition fully.**

Cal Poly Humboldt offers numerous scholarships for Nursing students. The application is generally open from mid-November through January 31st prior to the academic year.

All CEP students must register at CR for (9) units and Cal Poly Humboldt for three (3) units before being considered for a full-time financial aid award. However, you will not be eligible for state university and Cal grants when enrolled in less than (6) units at Humboldt.

Students who already have a bachelor's degree when they enter the CEP program are not eligible for grants, but they may request a loan if eligible. State University Grants (SUG) are awarded to eligible students taking six (6) units or more at Cal Poly Humboldt.

At any point during the CEP program, the Cal Poly Humboldt Office of Financial Aid will be notified if the student is not registered for at least 12 units per semester. The Financial Aid staff will then reassess student eligibility for financial aid and readjust the award as federal and university guidelines require. This may result in a billing of financial aid already received.

## Requests for Accommodations -Cal Poly Humboldt

## **NCLEX-RN**

All CEP students should plan on take and pass the NCLEX-RN the summer after graduation from the CR program to be eligible to continue the CEP pathway/program. NCLEX-RN units cannot be awarded and noted on the CSU transcript until the student successfully passes this examination. The office of the Registrar reviews student transcripts and determines the number of NCLEX-RN units that can be awarded during or before the semester of BSN graduation. If the graduate check is deficient in required coursework (e.g., Upper Division GE courses) or units, the ADN-to-BSN student must enroll in additional CSU semester coursework to meet graduation requirements.

## **Frequently Asked Questions Regarding Participation in the CEP Program**

### **Who can apply to the Concurrent Enrollment Program (CEP)?**

All students who have completed the CR and Cal Poly Humboldt eligibility requirements are encouraged to apply.

### **Is the traditional ADN option being eliminated?**

No. Starting in Fall 2024, CR SON will offer students two cohort options for completing a nursing degree. The traditional ADN option will continue to be offered as described in the ADN Information Sheet. A second cohort option, the CEP pathway, will also be available for students who meet the eligibility requirements. The number in each cohort may vary depending on the applicant pool. Students in each cohort will complete the same ADN courses and participate in equivalent clinical experiences; however, the CEP students will also complete complementary BSN courses at the same time as their ADN courses.

### **Can I apply for admission to the CEP and the traditional ADN nursing cohorts?**

Yes, students may select the CEP pathway option (if eligible) and the traditional ADN program option. Students in either option will be ranked and selected based on the CR ADN enrollment criteria.

**Where does the program take place?**

The CR nursing courses will be offered in the CR School of Nursing and at partnering healthcare agencies in Humboldt/ Del Norte County. The CSU courses will be offered in a hybrid format. CEP students must attend two 1-day face-to-face intensives each semester, one in-person at the Humboldt campus and one virtual, via Zoom.

**How does the CR-Cal Poly Humboldt CEP differ from other ADN-BSN partnerships?**

The CR-Cal Poly Humboldt CEP is an innovative partnership that has been established to allow students to receive financial aid from a participating university while still being able to benefit from community college grants such as the Promise or Board of Governor's (BOG) waiver.

Also, if a student follows the CR/Cal Poly Humboldt CEP pathway as described, the units required to complete the program (120 units) are equal to those of a student completing a traditional BSN program. This allows the students to complete coursework for both the ADN and BSN programs concurrently and complete the BSN requirements within 1-year after graduating from the CR ADN program. This benefit decreases both time and money requirements for participants.

**Are the CR ADN nursing courses the same for CEP and traditional ADN students?**

Yes, the CR ADN nursing courses are the same for all enrolled students. The difference is that the CEP students will take concurrent and complementary CSU coursework each semester.

**Can I switch my spot if I accept a place in the CEP cohort and decide that I would rather be (or need to be) in the traditional cohort?**

No. You will have to decline your spot and be placed back into the applicant pool the following (students have to reapply the next application cycle) semester. Your readmission into the program the next semester is not guaranteed; your application points will be ranked within that cohort of students.

**What if I graduate from CR and I cannot transition with my cohort to Cal Poly Humboldt due to severe or medical extenuating reasons?**

Suppose you cannot transition with your cohort to the CSU after graduation from CR for medical or educational reasons. In that case, you must complete the medical or educational leave paperwork with Cal Poly Humboldt. Please complete the appropriate paperwork to maintain good standing with the university. Further, if a student exceeds the timeframe for returning after a leave, he/she will have forfeited their right to remain enrolled under the CEP agreement in which they entered the program. If a student later decides to return to the university, the CEP student will need to reapply for admission to the traditional ADN-BSN program offered at Cal Poly Humboldt and meet all university's admission requirements, including GPA.

**What grade point average must I maintain while completing the CEP coursework?**

You must maintain good academic standing and a 2.0 grade point average in all CR and Cal Poly Humboldt CEP coursework to remain in the program.

**What if I fail or withdraw from the CR ADN coursework while enrolled in the CEP? If they fail CR during 1st semester, they must reapply during the next application cycle; if it is 2nd to 4th semester, they will be prioritized to return, depending on seat availability.**

A student who fails or withdraws from the CR ADN coursework will forfeit their position in the CEP program and will be required to reapply to CR for admission to the ADN program as outlined in the *CR School of Nursing Eligibility for Readmission/Transfer/Advanced Placement and Prioritization of Readmission/Transfer/Advanced Placement Candidate policies*. Additionally, students would be required to withdraw totally from the Cal Poly Humboldt coursework portion of the CEP program at the end of the semester and would not lose the CSU credits they have successfully completed. After successful completion of the ADN program, students would need to apply for the traditional ADN-to-BSN option offered at the CSU campuses. Students would need to meet all university admission requirements at the time of readmission to the CSU.

- **Students who opt to stay in the CEP while repeating a course in CR will be evaluated on a case-by-case basis. If a student withdraws or is dismissed from the CR nursing program, the student will automatically be dismissed from the Cal Poly Humboldt Nursing Program (2) Students who request to repeat the Cal Poly Humboldt CEP program will be evaluated on a case-by-case basis. Students would need to meet with the CEP Coordinator and RN-BSN advisor to request readmission to the Cal Poly Humboldt nursing program.**

**What if I fail or withdraw from the Cal Poly Humboldt coursework while enrolled in the CEP?**

A student who fails or withdraws from the CSU coursework while enrolled in the CEP program is eligible to complete the CR ADN program but would forfeit their CEP position at the Cal Poly Humboldt. Students would need to reapply to the university's traditional ADN-to-BSN option after completion of the ADN program. Students who apply for readmission to the CSU must meet all university admission requirements.

**If I am not accepted into the CEP pathway, am I still eligible for the traditional ADN pathway?**

Yes, students may choose, at the time of application, to select one or both program pathways.

**So, will I be a Community College or a University student?**

As an NCCEP student, you will enjoy the benefits and services of both institutions in which you are enrolled. You will also proudly display a patch on your uniform indicating you are a student enrolled in the NCCEP program.

**What course pattern will I complete in the CEP program pathway?**

The course pattern will differ slightly depending on the designated university. See Tables 2 and 3 below, which describe the concurrent pathways for each university.

BSN applicants can transfer 54 units of GE and nursing prerequisites and they can transfer 16 units from their ADN program, totaling up to a maximum of 70 units. Seventeen units of credit from the applicant’s NCLEX exam will be applied to the BSN program towards the BSN degree. Students complete 27 units of upper division nursing courses, and an additional 6 units of upper division general education (UDGE) courses in areas C and D will be taken to meet the requirement of 120 units.

The Upper Division Area B General Education requirement is met by the coursework within the nursing major. The department suggests that students select Upper Division GE area C and area D courses that also meet Diversity and Common Ground (DCG) requirements. Recognizing the increasing cultural diversity of California's population and the importance of understanding diverse cultural experiences, identities and how differential privilege and power are organized, the University requires that students complete a Diversity and Common Ground (DCG) requirement as part of the baccalaureate degree program. Undergraduates must complete at least two DCG courses; one of these courses must be designated domestic (focused within the boundaries of the United States) while the second course may either be domestic or international/transnational (non-domestic) in focus. Students may meet the DCG requirement with courses that simultaneously meet other degree requirements (general education, the major or minor, US institutions, or the elective component).

<b>Step 1</b>	Student consults with CR Counselor about the course requirements for CR and Cal Poly Humboldt nursing programs.
<b>Step 2</b>	Student attends CEP Information Session.
<b>Step 3</b>	The student applies for the CR-Cal Poly Humboldt CEP application pool.
<b>Step 4</b>	Applicants take the TEAS test at any authorized testing site. All TEAS test results must be submitted with the application.
<b>Step 5</b>	The CR Nursing Enrollment and Evaluation Specialist and CR Admissions and Records verify applicant eligibility. Modified GE verification is completed.
<b>Step 6</b>	Applicants are ranked according to the CR enrollment criteria.
<b>Step 7</b>	Applicants selected for placement are notified of status from CR and Cal Poly Humboldt. Applicants will accept or refuse placement.
<b>Step 8</b>	Financial aid paperwork is completed, if needed.
<b>Step 9</b>	Enrollees attend a Mandatory Orientation and Welcome Session at CR.
<b>Step 10</b>	Enrollees attend a 2-day CR Boot Camp.
<b>Step 11</b>	Students begin CR and Cal Poly Humboldt coursework.
<b>Step 12</b>	Students graduate from CR and take NCLEX-RN.
<b>Step 13</b>	Students graduate from Cal Poly Humboldt and earn BSN degree.
