 - c. Close all window curtains.
 - d. Get all inside to safe location Kitchen area is best internal location.
 - e. If a police officer or higher official arrives, they will assume command.
 - f. Wait until notice of all is clear before unlocking doors.
 - g. If safe to do so, move to the nearest evacuation point outside building (Pooky's Park), directly behind the Hoopa Tribal Education Building.

CONCERT BAND MUS 61 – Eureka Campus

CA107/BANDROOM BRIAN A. NEWKIRK

COURSE TITLE: Concert Band

This course is 1 unit grade only CSU & UC transferrable

COURSE LENGTH: One semester; can be repeated four times for credit.

RECOMMENDED PREPARATION: Previous playing experience on a band instrument (brass, percussion, or woodwind), and/or Music 22, Beginning Band Instruments.

MATERIALS:

A. Sheet music

B. Supplemental text – Raymond C. Fussell, Exercises for Ensemble Drill

I. BRIEF DESCRIPTION OF THE COURSE

The study and performance of nineteenth and twentieth-century concert band literature. Course addresses rehearsal techniques, development of sight-reading and public performance skills, and historical background of the concert band repertoire.

II. MAJOR GOALS AND OBJECTIVES OF THE COURSE

1. Demonstrate an acceptable level of instrumental technique, as well as rhythmic and pitch accuracy, in performance of college- level band literature.
2. Identify and combine appropriate interpretative nuances and conventions in performance.
3. Exhibit effective collaborative skills within the ensemble, both in rehearsals and in public performance.

III. COURSE CONTENT

A. Music nomenclature/notation/accuracy in score reading.

B. Sight-reading strategies.

C. Public performance strategies.

D. Technique/approaches to solving problems of musical execution.

E. Warm-up exercises and approaches.

F. Performance practice/interpretative issues.

IV. TYPICAL ACTIVITIES

1. Playing warm up exercises.
2. Rehearsing previously learned repertoire.
3. Sight reading new music.
4. Sectional rehearsals.
5. Discussing the historical/cultural background of the music, performance practice considerations pertaining to particular genres and/or styles, and technical issues pertaining to particular passages.
6. Performing in public.

V. MEANS AND METHODS OF EVALUATION

1. Ratings achievement on skills (30% of final grade). This grade will be determined on the following basis:

A: Student demonstrates complete mastery of all, or nearly all, of the course's principal concepts.

B: Student demonstrates complete mastery of many of the course's principal concepts, and adequate mastery of all of them. C: Student demonstrates adequate mastery of most of the course's principal concepts.

D: Student is unable to demonstrate adequate mastery of several of the course's principal concepts.

F: Student demonstrates mastery of few or none of the course's principal concepts.

2. Rehearsal & class participation (30% of final grade). A student receives 10 participation points for each class attended. The final participation grade is calculated as follows:

A: 260 – 280 B: 240 – 250 C: 220 – 230 D: 200 – 210 F: under 200

3. Performance participation (40% of final grade). Participation in performances is a crucial component of the course, and is mandatory.
